ARTICLES OF INCORPORATION

OF

InterKey Coatings, Inc.

In compliance with the requirements of Florida Statutes Chapter 607, the undersigned, being a natural person, hereby act as Incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation is **InterKey Coatings, Inc.**

ARTICLE II

The existence of the corporation shall begin on acceptance by Florida Secretary of State.

ARTICLE III

The address of the principal office of the Corporation is 171 Hood Street, Suite #16, Tavernier, Florida 33070.

ARTICLE IV

The maximum number of shares this corporation is authorized to issue is Twenty [20], all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share upon all matters on which shareholders have a right to vote.

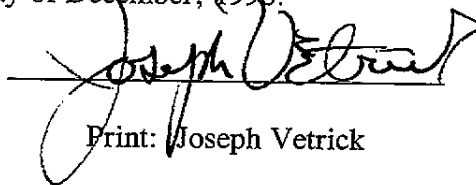

ARTICLE VII

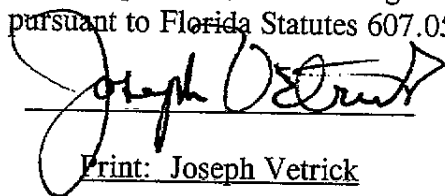
The corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.
