**ARTICLES OF INCORPORATION  
OF  
TOXIC TONY'S, INC.**

**ARTICLE I - NAME**

The name of this Corporation is TOXIC TONY'S, Inc.

**ARTICLE II - NATURE OF BUSINESS**

This Corporation will engage in the operation of a bar and restaurant and may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

**ARTICLE III - CAPITAL STOCK**

The maximum number of shares this corporation is authorized to issue is 500 shares of ONE DOLLAR (\$1.00) par value common stock which will be designated as "Common Shares."

**ARTICLE IV - TERM OF EXISTENCE**

This Corporation is to exist perpetually.

**ARTICLE V - PREEMPTIVE RIGHTS**

Every Stockholder, upon the sale for cash of any new stock of this Corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

**ARTICLE VI - PRINCIPAL OFFICE AND MAILING ADDRESS**

The initial street address of the principal office and the mailing address of this Corporation is 7900 103rd St. #9, Jacksonville, Florida 32210.

**ARTICLE VII - DIRECTORS**

This Corporation shall have one Director initially. The number of Directors may be increased or diminished from time to time, by Bylaws adopted by the Stockholders.

ARTICLE X - INITIAL REGISTERED OFFICE AND AGENT

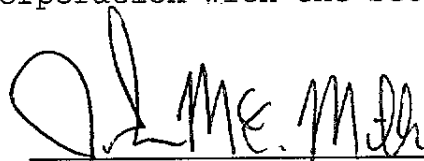

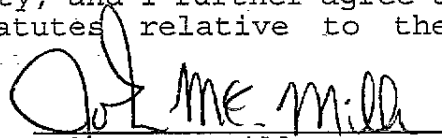
