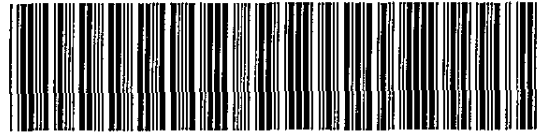



This Amendment was approved by the shareholders of the corporation and the number of votes cast for the amendment by the shareholders were sufficient for approval.

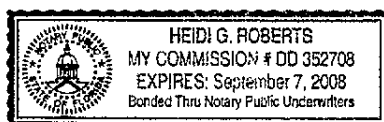
