**ARTICLES OF INCORPORATION  
OF

The undersigned, acting as incorporator of Community Supermarket, Inc., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

**ARTICLE I: NAME**

**ARTICLE III: COMMENCEMENT OF EXISTENCE**

The existence of the corporation will commence at 12:01 a.m. on the date of filing of these Articles of Incorporation.

**ARTICLE V: AUTHORIZED SHARES**

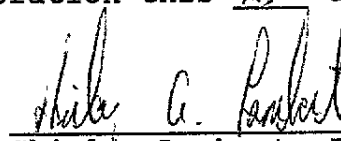
**ARTICLE IX: BYLAWS**

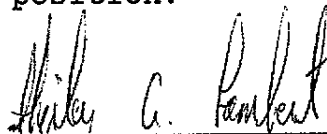
