The undersigned hereby organizes a professional corporation for profit under Chapters 607 and 621, Florida Statutes, and pursuant to the following Articles of Incorporation.

ARTICLE 1

Name

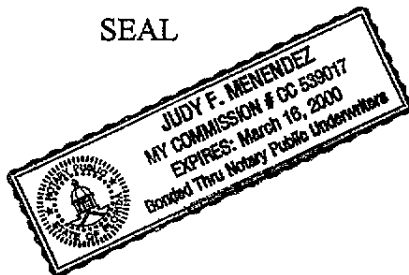
