# ARTICLES OF INCORPORATION

OF IMAGES BY KATHY, INC.



## ARTICLE I. NAME

The name of this corporation shall be IMAGES BY KATHY, INC.

EFFECTIVE DATE

ARTICLE II. COMMENCEMENT & DURATION
