ARTICLES OF INCORPORATION

The undersigned Incorporator hereby forms a corporation under the laws of the State of Florida:

ARTICLE I. CORPORATE NAME

The name of the Professional Association is:

GHASSAN T. HAMADY, M.D., P.A.

ARTICLE II. MAILING ADDRESS OF CORPORATION

The initial mailing address of the Professional Association shall be 7150 West 20th Avenue, Suite 209, Hialeah, Florida 33016.

ARTICLE III. CAPITAL STOCK

The aggregate number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is One Hundred (100) shares of common stock having a par value of One (\$1.00) Dollar per share. The Board of Directors of this Corporation shall have the power to divide and issue the Common Stock into one or more series and to determine the limitation and relative rights of each such series, consistent with the laws of the State of Florida. Shares of one series may be issued as a share dividend in respect of shares of another series.

ARTICLE IV. NATURE OF CORPORATION

This Corporation, through its officers and employees, shall be authorized to engage in ever aspect and phase of the practice of medicine within the State of Florida; to engage in any activities

which will facilitate and promote the practice of medicine through its officers and employees, and to invest and reinvest its funds in real estate, mortgages, stocks, bonds and any other type of investments within the meaning of Section 8 of the Professional Service Corporation and Limited Liability Company Act; and to purchase and own real and personal property necessary for the rendering of professional services within the practice of medicine. This Corporation shall not be authorized to engage in any business other than the practice of medicine.

ARTICLE V. COMMENCEMENT AND TERM OF EXISTENCE

This Corporation shall commence its corporate existence on December 28th, 1998. This Corporation shall have perpetual existence.

ARTICLE VI. INITIAL REGISTERED OFFICE AND REGISTERED AGENT.

The street address of the initial registered office of this Corporation in the State of Florida and the Corporation's initial registered agent at that office shall be MARSHA G. MADORSKY, ESQ., 2665 South Bayshore Drive, Suite 603, Miami, Florida 33133

ARTICLE VII. BOARD OF DIRECTORS

The number of directors may be increased or decreased from time to time as provided in the By-Laws, but shall never be less than one (1). The initial director shall be GHASSAN T. HAMADY, whose address is 7150 West 20th Avenue, #209, Hialeah, FL 33016.

ARTICLE IX. AMENDMENT

These Articles of Incorporation may be amended in the manner prescribed by law, except that upon the issuance of shares, every amendment must be approved by the Board of Directors of the Corporation before it is submitted to the shareholders of the Corporation for their approval.

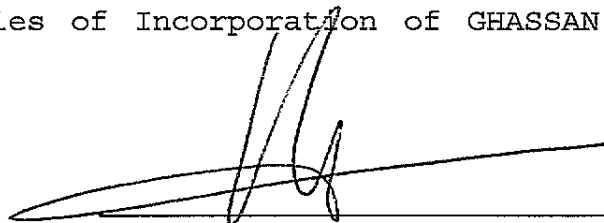
ARTICLE X. INDEMNIFICATION
