

ARTICLES OF INCORPORATION
OF
DO ALL SERVICES OF SOUTHWEST FLORIDA, INC.

The undersigned subscriber to these Articles of Incorporation, David Wolff, being a natural person competent to contract, hereby acknowledges and files these ARTICLES OF INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the laws of the State of Florida.

ARTICLE I

CORPORATE NAME

The name of this Corporation is DO ALL SERVICES OF SOUTHWEST FLORIDA, INC. The principal office and mailing address of the corporation is 5308 Treetops Drive, Naples, Florida 34113.

ARTICLE II

DURATION

The Corporation shall have perpetual existence, commencing upon January 1, 1999.

ARTICLE III

PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV

CAPITAL STOCK

The Corporation is authorized to issue 1000 shares of \$1.00 par value stock, which shall be designated "common shares." 
