THE UNDERSIGNED, ACTING AS INCORPORATOR OF A CORPORATION UNDER THE FLORIDA BUSINESS CORPORATION ACT, ADOPTS THE FOLLOWING ARTICLES OF INCORPORATION:

FIRST: The name of the corporation is Bluewater Navigation, Inc.

<u>SECOND</u>: The period of its duration is perpetual.

THIRD: The date and time of the commencement of the corporate existence shall be January 1, 1999.
