ARTICLES OF INCORPORATION

of



CORPORATE SECURITY SPECIALISTS, INC.

The undersigned hereby states, for the purpose of forming a corporation under the laws of the State of Florida, providing for the formation, rights, privileges, immunities, and liabilities of corporation for profit, as follows:

ARTICLE I - NAME

The name of this corporation, (hereinafter referred to as the "Corporation") shall be:

CORPORATE SECURITY SPECIALISTS, INC.

ARTICLE II - PURPOSE

This Corporation is organized for the purposes of:

- A. Establishment and management of professional research and investigative services for client corporations, individuals, government entities and the public generally, and,
