**ARTICLES OF INCORPORATION**

**ARTICLE I**

The name of the corporation is Jubilee Years, Incorporated. The principal business address and mailing address of the corporation is:

275 Palm Ave., A-101, Jupiter, FL 33477

**ARTICLE II**

The corporation shall have perpetual existence.

**ARTICLE III**

The corporation is organized for the purpose of the transaction of any and all lawful business for which corporations may be incorporated, pursuant to Chapter 607, Florida Statutes, known as the Florida Business Corporation Act.

**ARTICLE IV**

The corporation is authorized to issue ten thousand (10,000) shares of Class A Common stock at no par value each and twenty thousand (20,000) shares of Class B Common stock at no par value each. All shares shall have the same rights and privileges regardless of class, except that the Class A shares shall have all voting rights, with each Class A share having one (1) vote and each Class B share having no vote.

**ARTICLE V**

The street address of the initial registered office of the corporation is 275 Palm Ave., A-101, Jupiter, FL 33477, and the name of the initial registered agent of the corporation at that address is Philip R. Wolf.

#### ARTICLE VI

The corporation shall have initially two (2) directors. The number of directors may be either increased or decreased from time to time as determined by the Bylaws.

The Bylaws of the corporation may be adopted, altered, amended, or repealed by either the Board of Directors or the shareholders. Any Bylaw adopted by the Shareholders may provide that one or more provisions thereof shall not be altered, amended or repealed by the Board of Directors, in which case such provisions may be amended, altered or repealed only by the shareholders.

#### ARTICLE IX

The corporation shall indemnify any officer or director, or any former officer or director to the full extent permitted by law.

#### ARTICLE X

The corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment thereto, and any right conferred upon the shareholders is subject to this reservation.
