I. NAME AND MAILING ADDRESS

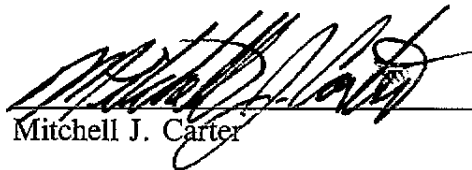
VI. DIRECTORS

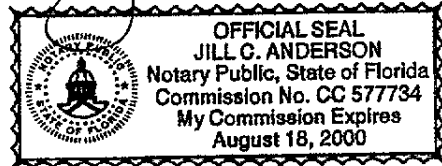
