The undersigned incorporator Mark E. Cordr y, hereby forms SOUTHERN SUPPLY STORE, INC., a corporation for profit under the Florida General Corporation Act and other laws of the State of Florida.

1. NAME OF CORPORATION AND INITIAL ADDRESS: The name of this corporation shall be SOUTHERN SUPPLY STORE, INC. and its address is 720 1/2 Magnolia Avenue, Panama City, Florida 32401.

2. TERM OF EXISTENCE: This corporation shall exist perpetually unless dissolved according to law.



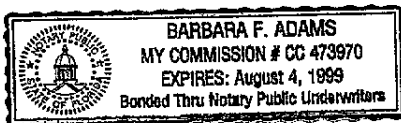


