ARTICLES OF INCORPORATION

OF

KWON'S GAS MART, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following articles of incorporation:

ARTICLE ONE

The name of this corporation is KWON'S GAS MART, INC.


