The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be: St. John, Dicker, Caplan, Krivok & Core, P.A.

ARTICLE II PRINCIPAL OFFICE

ARTICLE V EFFECTIVE DATE

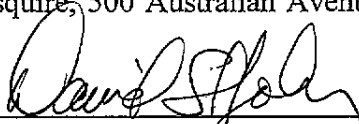
The effective date of this corporation shall be January 1, 1999.

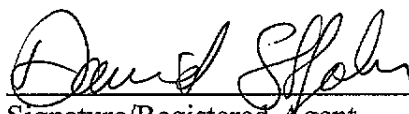
