#### ARTICLES OF INCORPORATION

The undersigned incorporator(s), for the purpose of forming a Corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

### ARTICLE I NAME

Two or more persons who are the joint registered owners of one or more shares shall be counted as one shareholder.
- 4. Any invitation to the public to subscribe for securities of the Corporation is prohibited.
