This address is the same as the principal place of business and the mailing address of the corporation.


6. The initial Board of Directors shall have 2 member whose name's and address are as follows:

BARBY JO ANDERSON, Secretary/Treasurer, 8012 Plaza Drive, Tampa, FL 33615.


