**ARTICLE VI. EFFECTIVE DATE**

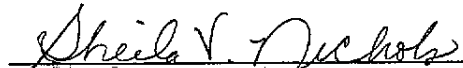

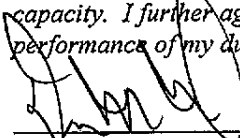
