The undersigned Subscriber hereby makes, subscribes, acknowledges, and files with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with Chapter 607, Florida Statutes, known as the Florida Business Corporation Act (FBCA).

ARTICLE ONE

NAME OF CORPORATION

The corporate name that satisfies the requirements of Section 607.0401 is: Michael J. Spoto, Inc.

ARTICLE TWO

ADDRESS OF CORPORATION

The address of the principal office is 401 South Florida Avenue, Suite 201, Tampa, Florida 33602, and the mailing address of the corporation is Post Office Box 1347, Tampa, Florida 33601-1347.

ARTICLE THREE

STOCK

The number of shares the corporation is authorized to issue is: 10,000 shares, all of which shall be common shares with a par value of \$1.00.

ARTICLE FOUR

PURPOSE

The purpose for which this Corporation is organized is to transact any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

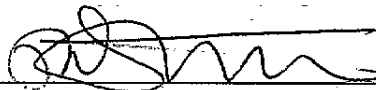

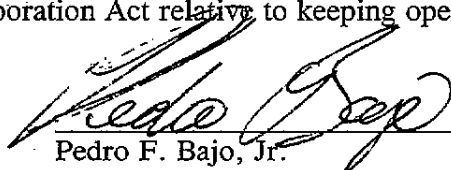
