# ARTICLES OF INCORPORATION of SECRETARY OF STATE ADARA REALTY SERVICES, INC. TALLAHASSEE, FLORIDA

The undersigned incorporator, hereby forms a corporation in accordance with Florida law and adopts the following articles of incorporation for the corporation:

#### ARTICLE I
