ARTICLES OF INCORPORATION  
OF

GEORGE HIGGINSON THE REPAIRMAN, INC.

ARTICLE I - NAME:

The name of this corporation is: GEORGE HIGGINSON THE REPAIRMAN, INC., hereinafter referred to as the "Corporation".

ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon January 1, 1999.

**EFFECTIVE DATE**

1-1-99

ARTICLE III - PURPOSE:

The Corporation is organized for the purpose of engaging in the Home Maintenance and Repair business and for the purpose of transacting any or all other lawful business not inconsistent with the Laws of the State of Florida.

ARTICLE IV - CAPITAL STOCK:

The Corporation is authorized to issue 100,000 shares of One Dollar (\$1.00) par value common stock.

ARTICLE V - PRE-EMPTIVE RIGHTS:

Every shareholder, upon the sale for cash of any new stock of the same kind, class or series as that which he or she already holds, shall have the right to purchase his or her pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT:

The principal office and street address of the Corporation is: 33 Choctawhatchee Rd., S.E., Ft. Walton Beach, FL 32548 and the mailing address is: 33 Choctawhatchee Rd., S.E., Ft. Walton Beach, FL 32548.

ARTICLE VII - INITIAL BOARD OF DIRECTORS:

The Corporation shall have one director initially. The number of directors may be either increased or decreased from time to time by the By-Laws but shall never be less than one. 
ARTICLE IX - BY-LAWS:
