ARTICLES OF INCORPORATION

OF

GEORGE HIGGINSON THE REPAIRMAN, INC.

ARTICLE I - NAME:

The name of this corporation is: GEORGE HIGGINSON THE REPAIRMAN, INC., hereinafter referred to as the "Corporation".

ARTICLE II - DURATION:
