# ARTICLE I

## Name

## Term of Existence

The date when corporate existence shall commence shall be December 30, 1998, as provided by Section 607.0203 of the Act, and the Corporation shall have perpetual existence thereafter.

# Principal office



- (b) In the election of directors of this corporation, there shall be no cumulative voting of the stock entitled to vote at such election.
