We are in receipt of your letter dated October 29, 2001. We are puzzled by your letter which sets forth that we had not submitted payment.

Despite the fact that it had been represented to us during two or three telephone conversations late last year that we had made payment and filed a report, we submitted this latest payment (on December 11, 2001) because we were concerned that we had not received from the Division of Corporations our Annual Report request for the fiscal year 2001-2002.

We believe that there continues to be some confusion regarding the current "Law Offices of Grady C. Irvin, Jr., P.A." and the predecessor professional association known as "Grady C. Irvin, Jr., P.A." We believe this confusion existed when we were told in October/November/December 2000 that the payment and report had been received. We have continued to receive information from the Division of Corporations regarding the predecessor "Grady C. Irvin, Jr., P.A." For example, we are enclosing mailings we have on file regarding a request of this predecessor corporation for its 2000 report. We also note your letter to us on October 29, 2001 states "we have received your check(s) totaling \$900.00." We have never submitted a check for \$900.00.



Ms. Ashton, we have acted in good faith, with diligence, and in reliance on our communications with the Division of Corporation. As your records might reflect, the Division of Corporations has made several mistakes in their communication with us, including, but not limited to the letter of October 29, 2001 stating that we submitted a check for \$900.00. The Division has dispatch mail to us with an incorrect address that we didn't receive for many, many months. We do not believe that we should be penalized for something which we did not cause.

As previously stated, the Division of Corporations informed us late last year that our filings were satisfied. Now, based upon our curiosity as to why we had not received a request for this years report and our initiative to send another check despite the representations of the Division that the report and check had been filed in late 2000, we are being penalized. We are requesting that this matter be reconsidered and that you accept our enclosed check and work with us in putting this matter squarely on track. We remain,
