ARTICLES OF INCORPORATION OF

EBBTIDE CHARTERS, INC.



ARTICLE I: NAME

The name of this corporation is **EBBTIDE CHARTERS**, INC., whose address, 315 N.E. Third Avenue, Suite 200, Fort Lauderdale, Florida 33301.

ARTICLE II: EFFECTIVE DATE AND DURATION

The effective date for the commencement of this corporation shall be January 4, 1999. This corporation shall have perpetual existence.

ARTICLE III: PURPOSE
