Articles of Incorporation

MCMANUS/LUGER CORPORATION

The undersigned persons, acting as incorporators for the purpose of forming a stock business S corporation under the laws of the State of Florida, adopts the following Articles of Incorporation.

Article 1 The name of the corporation is McManus/Luger Corporation.


Article 6. The effective date for this S corporation shall be January 1, 1999.
