OF

The undersigned, for the purpose of forming a corporation under the Florida Professional Corporation Act, Florida Statutes §621.01, et seq., hereby adopt the following Articles of Incorporation:

ARTICLE ONE

1.01 The name of this corporation is DAVID J. KRYNAUW, B.D.S., P.A.

ARTICLE TWO

2.01 The corporation is to have perpetual existence.

ARTICLE THREE

3.01 The purpose for which the corporation is organized is to practice dentistry. Further, the corporation shall have all powers permitted to a corporation under the Florida General Corporation Act as extended to a Florida Professional Service Corporation under Florida Statute §621.13.

ARTICLE FOUR

4.01 The aggregate number of shares which the corporation shall have the authority to issue is 1,000, all of which shall be common shares with a par value of \$1.00 per share.


ARTICLE EIGHT


