# ARTICLES OF INCORPORATION OF DAVID J. KRYNAUW, B.D.S., P.A.

EFFECTIVE DATE

The undersigned, for the purpose of forming a corporation under the Florida Professional Corporation Act, Florida Statutes §621.01, et seq., hereby adopt the following Articles of Incorporation:

### ARTICLE ONE

1.01 The name of this corporation is DAVID J. KRYNAUW, B.D.S., P.A.

2.01 The corporation is to have perpetual existence.

## ARTICLE THREE
