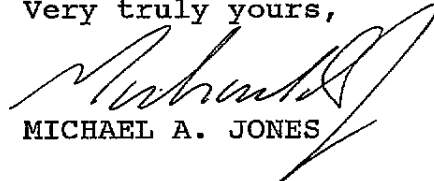

ARTICLES OF INCORPORATION
OF
LAWMEN OF NICEVILLE, INC.

In compliance with the requirements of *Florida Statute Chapter 607*, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is LAWMEN OF NICEVILLE, INC.

ARTICLE II

The existence of the corporation shall begin on December 28, 1998.

ARTICLE III

The street address of the principal office of the Corporation is 1408 Palm Boulevard, Niceville, Florida 32578.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is One Hundred (100), all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.
