Articles of Incorporation of BNY Yacht Services, Inc.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

EFFECTIVE DATE

The name of the corporation ("Corporation") is: BNY Yacht Services, Inc.

ARTICLE II

The existence of the corporation shall begin on January 1, 1999.

ARTICLE III
