ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF ALLSTATE FOOD MARKETING, INC.

Pursuant to the provisions of Florida Statute Section 607.1006, this corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is Allstate Food Marketing, Inc.
- 2. Article III of the Articles of Incorporation of Allstate Food Marketing, Inc. is hereby amended in its entirety to read as follows:

ARTICLE III

- A. Total Shares. The aggregate number of shares the corporation has the authority to issue are 100,000 shares, being no more than 75,000 shares of Class A Stock and 25,000 shares of Class B Stock (as defined in Paragraph B). All or any part of said capital stock may be paid for in cash, in property or in labor and services at a fair valuation to be fixed by the board of directors at a meeting called for such purposes. All stock when issued shall be paid for and shall be non-assessable.
- B. Classes and Rights. The shares of the corporation are divided into two classes of stock—Class A and Class B. The two classes of stock are identical in rights and powers except that the holders of Class B Stock shall have no voting power for any purpose. All voting power is vested exclusively in the holders of Class A Stock. Each Class A share of stock shall entitle the holder thereof to one (1) vote at any meeting of the shareholders.
- C. **Par Value.** Both Class A and Class B stock shall be issued at a par value of \$0.01.
- 3. This amendment to the Articles of Incorporation of Allstate Food Marketing, Inc. was unanimously adopted by the shareholders of the corporation on January 1, 2001, said amendment intended to become effective upon filing with the Florida Secretary of State.
