**ARTICLE I - NAME**

The name of this Corporation is **WORLD CLASS RESTAURANT RECIPES, INC.**

**ARTICLE II - DURATION**

This Corporation shall exist perpetually commencing on the date of the execution of these Articles.

**ARTICLE III - PURPOSE**

This Corporation is organized for the purpose of transacting any or all lawful business.

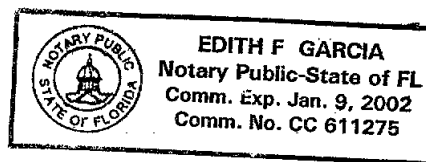
