ARTICLES OF AMENDMENT

OF THE

ARTICLES OF INCORPORATION OF

BRICKLEMYER SMOLKER, P.A.

Bricklemyer Smolker, P.A., a corporation organized and existing under the laws of the State of Florida (the "Corporation"), in order to amend its Articles of Incorporation in accordance with the requirements of Section 607.1001 et. Seq. of the Florida Business Corporation Act does hereby certify as follows:

1. The current name of this Corporation is BRICKLEMYER SMOLKER, P.A.
2. The Articles of Incorporation of the Corporation were filed with the Secretary of State of the State of Florida on December 31, 1998, and subsequently amended by Articles of Amendment filed January 23, 2013.
3. The Articles of Incorporation of the Corporation are amended as follows: the first Article thereof is deleted in its entirety and replaced as follows:

ARTICLE 1

NAME

The name of this corporation shall be: SMOLKER, BARTLETT, SCHLOSSER, LOEB & HINDS, P.A.

4. This amendment of the Articles of Incorporation was recommended to the shareholders by the unanimous consent of the Board of Directors on February 18, 2013. This
