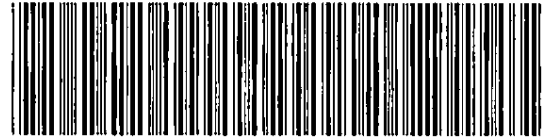

Pursuant to Section 607.1101 of the Florida Statutes, the undersigned corporations, MAY NURSERY, INC., a Florida corporation ("Surviving Company"), and MAY TOBACCO, INC., a Florida corporation ("Merging Company"), adopt the following Articles of Merger for the purpose of merging the Merging Company into Surviving Company effective the date of filing with the Florida Secretary of State.

1. The name and jurisdiction of formation of the Surviving Company is as follows:
