OF

Article I
Name of Corporation

The name of this Florida corporation is Cruiser 1 Corporation (the "Corporation").

Article II
Purpose

The Corporation is organized for the purpose of transacting any or all lawful business for corporations organized under The Florida Business Corporation Act of the State of Florida.

Article III
Address of Corporation

Article IV
Common Stock

The Corporation shall have the authority to issue 100 shares of common stock. For documentary stamp tax purposes only, the par value of the Corporation's common stock shall be \$.01 per share.

Article VI
Incorporator

Article VI
Board of Directors

The affairs of the Corporation shall be managed by a Board of Directors consisting of no less than one director. The number of directors may be increased or decreased from time to time, in accordance with the Bylaws of the Corporation, but shall never be less than one. 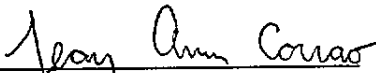

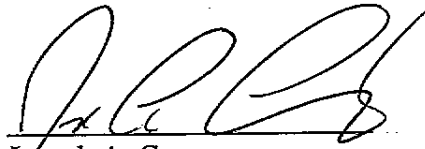
