ARTICLES OF INCORPORATION

ARTICLE I NAME

The name of the Corporation is: THE SALON AT SUN CITY CENTER, INC., which is not a member of any affiliated group.

ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 717 Imar Drive, Sun City Center, FL 33573.

The principal mailing address of this corporation shall be: 717 Imar Drive, Sun City Center, FL 33573.

ARTICLE III PURPOSE

The general purposes for which the Corporation is organized are:

1. To engage in the business of beauty salon, hair treatment, nail care, wig services for cancer patients and any other related services; and
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the Board of Directors of the Corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
3. To do such other things as are incidental to the foregoing or necessary in order to accomplish the foregoing.

ARTICLE IV CAPITAL STOCK


ARTICLE VII INCORPORATOR
