# ARTICLES OF INCORPORATION OF JMR GROUP, INC.

The undersigned, desiring to form a corporation for profit under the laws of the State of Florida, hereby certifies:

FIRST: The name of the corporation shall be:

# JMR GROUP, INC.

SECOND: The place in Florida where its principal office is to be located is: 2455
East Sunrise Boulevard, Suite 307, Fort Lauderdale, Broward County,
Florida 33304.

THIRD: The purpose for which the corporation is formed is to engage in any lawful act or activity for which corporations may be formed under the laws of the State of Florida.

FOURTH: The maximum number of shares which the corporation is authorized to have outstanding is Five Million (5,000,000) shares which shall consist of:

  - (4) Each class of shares shall be treated equally upon the dissolution, termination or winding up of the corporation.
