ARTICLES OF INCORPORATION

ALAN M. MARDER, D.M.D., P.A.

The undersigned, being licensed to practice dentistry in the State of Florida, desiring to form a professional corporation in accordance with Chapter 607 of the Florida Statutes and the Florida Professional Service Corporation Act, adopts the following Articles of Incorporation:

I. NAME

The name of the corporation shall be Alan M. Marder, D.M.D., P.A.

II. PURPOSE

The purpose for which the corporation is organized is to practice the profession of dentistry.

III. DURATION

The existence of the corporation shall commence January 1, 1999, and continue for perpetuity.

IV. CAPITAL STOCK

The number of shares of stock that the corporation is authorized to have outstanding is 100, all of which shall be common shares with par value of \$1.00.

V. CAPITAL

The business of the corporation shall be managed by the shareholders of the corporation rather than by a Board of Directors.

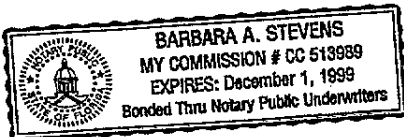

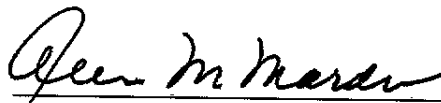

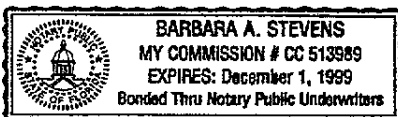
