ARTICLES OF INCORPORATION OF

Cyberight Corporation

The undersigned incorporator, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following articles of incorporation:

ARTICLE ONE NAME & ADDRESS

The name of the corporation is Cyberight Corporation. Its principal office and place of business is located at 402 Seabreeze Blvd., Suite H, P.O. Box 6003, Daytona Beach, Florida 32122-6003.

ARTICLE TWO CORPORATE DURATION

The duration of the corporation is perpetual.

ARTICLE THREE PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are:

1. To engage in the service of providing a searchable recording system which establishes proof of publication of the fact, contents, date and ownership of web site pages published on the Internet.
2. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

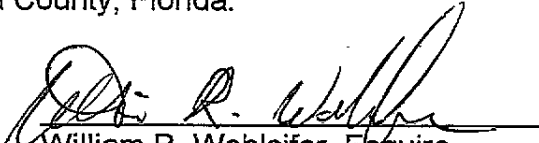
