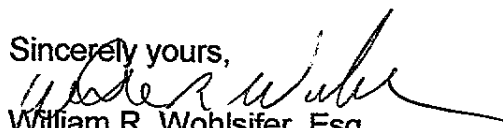

ARTICLES OF AMENDMENT
PERTAINING TO:
Cyberright Corporation

Pursuant to the provisions of Section 607.187 of the Florida Statutes, this corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The following amendments to the articles of incorporation were adopted by the directors of the corporation in the manner prescribed by the Florida General Corporation Act:

- a) **ARTICLE ONE (NAME & ADDRESS)** being amended as follows:

The corporation's principal place of business shall be located at 1111 K Street, Suite 304, Washington, D.C. 20006.

- b) **ARTICLE THREE (PURPOSE OR PURPOSES)** being amended as follows:

The general purposes for which the corporation is organized are:

1. To engage in a service that provides a **searchable recording system** which establishes proof of publication of the fact, time and date of text, images, graphics and/or sounds that are published, transmitted or otherwise appeared or were accessible via the Internet or World Wide Web in the form of Web pages, billboards, e-mails or otherwise.
2. To engage in a service that provides a process similar to that which **recording clerks** of local governments use to record deeds and mortgages and that which is used by government and private copyright registries in that the service provides authentication of documents, except that such service is modified for application on, to or for the Internet and World Wide Web.
3. To engage in a service that provides **neutral disinterested third party proofs** of Internet publication and electronic communications to be used by attorneys as evidence in litigation.

4. To engage in a service that provides evidentiary support of **prior use** in commerce of Internet publications and electronic communications.
5. To engage in a service that provides evidence in support of the **prior creation** of works of original authorship, such that such the service is analogous to that offered by writer's guilds and copyright registries, except that such service is modified for application on, to or for the World Wide Web.
6. To engage in the business of offering **affidavits and oral testimony** of records custodians to proffer evidence of publications or electronic transmissions that appeared or were accessible via the Internet or World Wide Web.
7. To engage in the service of maintaining a **Global depository** that archives and preserves Internet publications and electronic communications.
8. To engage in the business of providing a service that **periodically scans, downloads and archives** Web sites to provide proof of changes, revisions, additions and deletions.
9. To engage in the business of providing **notice to the Universe** that a particular Web site, Web page or transactional page has been or may be recorded, archived and preserved in a redundant offline secure database.
10. To do such **other things** as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

c) **ARTICLE FOUR (CAPITALIZATION)** being amended as follows:

The aggregate number of shares which the corporation is authorized to issue is **TEN MILLION SHARES** (10,000,000). Such shares shall be of a common single class, and shall have a par value of FIFTEEN CENTS (\$.15) per share.

d) **ARTICLE SEVEN (BOARD OF DIRECTORS)** being amended as follows:

The number of directors constituting the board of directors of the corporation is one (1). The names and address of the person who shall serve as the director is:

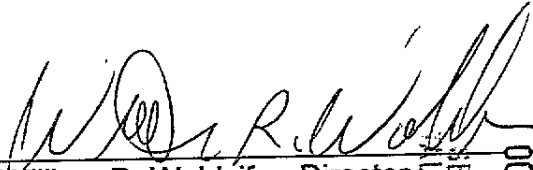
