ARTICLE I NAME

The name of the Corporation is: AMITY CONSULTANTS, INC., a domestic corporation which is not a member of any affiliated group.

ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 1708 Charleston Woods Court, Plant City, Florida 33567.

ARTICLE III PURPOSE

The general purposes for which the Corporation is organized are:
