NAME

The name of the corporation is Inspection Insights, Inc.

GENERAL NATURE OF BUSINESS

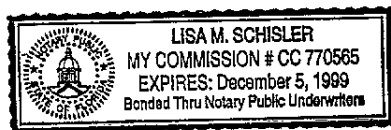
