

## ARTICLES OF INCORPORATION

#### GENERAL PERFORMANCE, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

#### ARTICLE I - NAME

The name of the corporation shall be GENERAL PERFORMANCE, INC. whose principal office and mailing address is 4279 N.W. 4th Court, Deerfield Beach, Florida 33442.
