ARTICLES OF INCORPORATION OF TAX PLANNING CONCEPTS, INC.

The undersigned, desiring to form a corporation for the purpose hereinafter stated, under and pursuant to the laws of the State of Florida, does hereby declare as follows:

ARTICLE I

The name of the corporation shall be TAX PLANNING CONCEPTS, INC.

ARTICLE II BUSINESS AND PURPOSE

The nature of the business which may be transacted by the corporation is as follows:

This corporation may engage in any activity or business permitted under the laws of the State of Florida, and shall enjoy all the rights and privileges of a corporation granted by the laws of the State of Florida.

ARTICLE III STOCK

The maximum number of shares of stock which this corporation is authorized to have outstanding at any time shall be One Thousand (1,000) shares of common stock, and shall be \$.01 par value per share. The capital stock may be paid for in property, labor or services at a just valuation, to be fixed by the incorporators or by the directors at a meeting called for such purpose, or at the organization meeting. Stock in other corporations or going businesses may be purchased by the corporation, in return for the issuance of its capital stock, and said purchases shall be on such

basis and for such consideration as the issuance of so much of the capital stock as the directors of the company may decide.

ARTICLE IV TERMS OF EXISTENCE

This corporation shall have a perpetual existence unless sooner dissolved according to law.

ARTICLE V PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office or place of business of the corporation and mailing address shall be located at 14409 69th Drive North, Palm Beach Gardens, Florida 33418, with privilege of having its offices and branch offices at other places within or without the State of Florida.
