ARTICLES OF INCORPORATION

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I: NAME

The name of the corporation shall be V. S. P. ENTERPRISES, INC., and the principal place of business of this corporation shall be 2307 9TH Street East, Bradenton, FL 34208, and the mailing address shall be the same.

ARTICLE II: NATURE OF BUSINESS

This corporation shall engage in all aspects of the contracting business and otherwise to engage in any other business that is for lawful purposes for which the corporation may be permitted by law pursuant to Chapter 607, Florida Statutes (1994).

ARTICLE III: CAPITAL STOCK

This corporation shall be for profit and the maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1,000 shares of common stock having a par value of \$200 per share.

#### ARTICLE IV: ADDRESS

The street address of the initial registered office of the corporation shall be 406 13th Street West, Bradenton, FL 34205, and the name of the initial registered agent of the corporation is JEFFREY S. GOETHE, Attorney.

#### ARTICLE V: TERM OF EXISTENCE

This corporation shall exist perpetually and shall commence as of the date it's Charter is issued by the Secretary of State of Florida.

This corporation shall have three directors initially. The number of directors may be increased or decreased from time to time by By-laws adopted by the stockholders, but shall never be less than one.

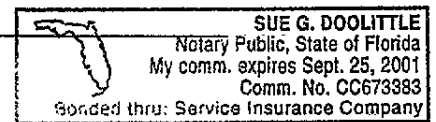
