The undersigned, a natural person, does hereby form a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation is **CURL UP 'N DYE, INC.**

ARTICLE II

The corporation may engage in any and all activities and businesses permitted under the laws of the United States and of the State of Florida. The corporation shall have all of the powers vested in a corporation organized under and existing by virtue of the laws of the State of Florida.

ARTICLE III

The maximum number of shares of stock which the corporation is authorized to issue and have outstanding at any time is 1,000 shares of common stock having a par value of \$1.00 per share.

ARTICLE IV

The existence of the corporation is perpetual. The principal place of business of the corporation is: **7000 S.W. 62 AVENUE, ONE 7000 PLACE, SOUTH MIAMI, FLORIDA 33143.**

ARTICLE V

The street address of the initial registered office of the corporation is **1550 Madruga Avenue, Suite #120, Coral Gables, FL 33146**, and the initial registered agent of the corporation at that address is **Richard J. O'Hare, Esq.**

The corporation shall have **ONE (1)** director(s) initially. The number of directors may be increased or diminished from time to time pursuant to the By-Laws of the corporation, but shall not be less than one nor more than seven.

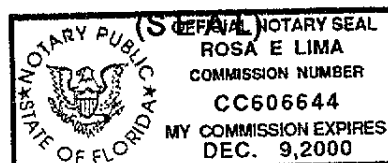
