CERTIFICATE OF INCORPORATION

ARTICLE I

NAME

ARTICLE IXAMENDMENT



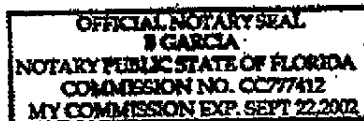
