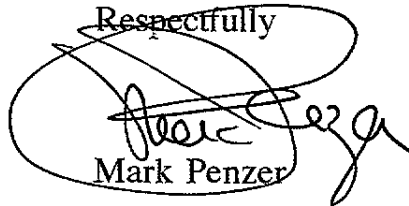

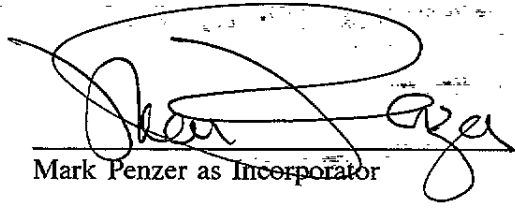

6. The Corporation elects to have preemptive rights.

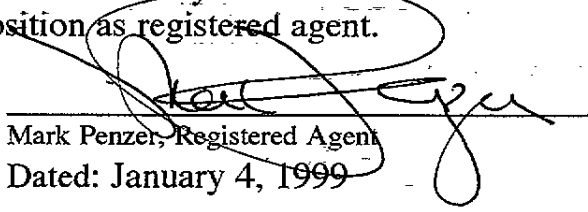
