We, the Fewells, have a real problem here and ask for your consideration in the reinstatement of our corporations, if they need to be reinstated.

When we received these enclosed forms, I called the department and explained that we never saw or received any other notice and was told to write a letter and send in check and forms.

This is where it gets worse. I filled out my form for Summit Financial and check with letter stating that I never received first notice. My husband was to do the same for Summit Construction. We were in the process of moving into our new attached offices and remodeling the same (major renovation) .

Summit Construction and Summit Financial were both without clerical at that time and jointly hired a person who has since left the area. To speed up this story, the paper work was given to Ms. Gomez to mail and copy.

On Wed. November 7<sup>th</sup>2003, in the bottom of a tall filing cabinet sat the papers. Summits Financials paperwork and check and Summit Constructions undated paperwork with missing check. Of course this was a real blow to us as we are both Sole owners of very small business's and penalties such as is stated by the paperwork would be a hardship of some magnitude.
