ARTICLES OF INCORPORATION
OF
Nou Tout Se Hypokrit, "St. Anne", Inc.
English Translation: (We're all Hypocrites, "Saint Anne", Inc.)

The undersigned, acting as incorporator of this corporation under the provisions of Chapter 607 of the Florida Statutes, as amended, adopts the following Articles of Incorporation:

ARTICLE I: NAME OF THE CORPORATION

The name of the corporation is Nou Tout Se Hypokrit, "SteAnne", Inc. (English translation: We're all Hypocrites, "Saint Anne", Inc.), hereinafter referred to as the "Corporation".

ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office is 15726 NW 7th Ave. Suite C Miami, Florida 33169. The mailing address is P.O. Box 530383 Miami, Florida 33153.

ARTICLE III: DURATION OF THE CORPORATION

The period of duration of the corporation shall be perpetual unless dissolved according to law.

ARTICLE IV: PURPOSE OF THE CORPORATION

The purpose for which the corporation is organized is to engage in any and all lawful business for which corporations may be incorporated in the State of Florida.

ARTICLE V: AUTHORIZE SHARES

The corporation is authorized to issue One Thousand (1,000) shares of common stock with a par value of \$1.00 per share. All stocks shall be of one class. The board of directors may authorize the issuance of such stock to such person(s) upon such terms and for such terms and for consideration, as they may deem appropriate. The consideration may consist of any tangible or intangible property or benefit the corporation, including cash, promissory notes, service performed, promises to perform services evidenced by written contract, or securities of the corporation.

ARTICLE VI: PREEMPTIVE RIGHTS

The corporation elects to have preemptive rights. Every shareholder, upon the sale for cash of any new or reissued stock of this corporation, shall have the right to purchase his prorata share thereof at the price at which it is offered to others.

ARTICLE VII: INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The street address of the corporation's initial registered office is 15726 NW 7th Ave. Miami, Florida 33169, and the registered agent at that office is Jacqueny Etienne.

ARTICLE VIII: INITIAL BOARD OF DIRECTORS

The corporation shall have one (1) Director constituting the initial Board of Directors. The number of directors may be increased or decreased from time by the bylaws. The initial Board of Directors or the Corporation shall be comprised of: President

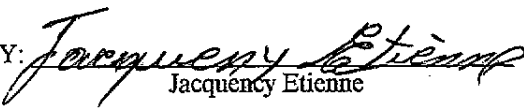
